

c. Sports Physiotherapy :- i. Sports books requirement in process,

ii. Equipment installation in Process

iii. Sports injury clinic /OPD case papers for individual patients need to be maintained.

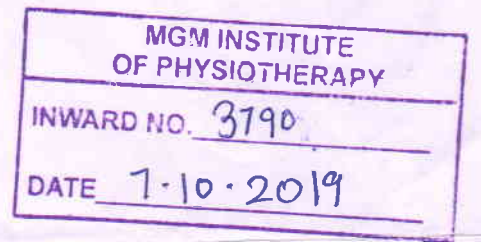
